Peer Support: intentional support offered from a current resident/fellow to another current resident/fellow who has knowledge from their own experiences or similar situations. This can be social, practical, or emotional support.

Re: QO SD 1

Date: January 25, 2022

The Commission on Accreditation in Practice Transition Programs (COA-PTP) has voted to clarify the below areas in the 2020 Practice Transitions Accreditation Program® Application Manual.

The COA-PTP has issued clarification on **QO SD 1**. New Language Below (in red):

QO SD 1. Submit a list of program goals (in **SMART goal** format) and associated quality outcomes. List must include a brief description of the outcome measures, target benchmarks, and aggregate data evaluated over the past 18 months, or from initiation of program to present if less than 18 months.

NOTE:

- To meet requirements of QO SD 1, programs utilizing published research tools for SMART goals must follow author requirements for tool use and data reporting. Author requirements for tool use must be followed to maintain its psychometric properties (validity and reliability) and integrity of its measures.
- All research tools used in QO SD 1 must be referenced.

Include one quality outcome measure from each of the following four categories (the program may choose to also report from the optional category of patient outcomes):

1. Nursing professional development

Suggested measures may include but are not limited to:

- Academic progression for new residents/fellows (e.g., AD to BSN; BSN to MSN; BSN to DNP; MSN to DNP)
- Leadership progression (resident/fellow)
- Organizational advancements in areas such as presentations, publications, **evidence-based projects** implemented, and research studies

2. Practice-based knowledge, skills, and attitudes

Suggested measures may include but are not limited to:

- Resident/fellow clinical decision-making ability
- Resident/fellow clinical proficiency

3. Self-reported

Suggested measures may include but are not limited to:

- CNO/executive leader satisfaction
- Nurse Manager satisfaction
- Organizational commitment
- Participant/nurse (RN) satisfaction
- Preceptor satisfaction

4. Financial

Suggested measures may include but are not limited to:

- Return on investment
- Retention or turnover rate
- Vacancy rate
- Participant successful completion rate

Optional outcome measure category:

5. Patient outcomes

Suggested measures may include but are not limited to:

- Clinical outcomes: error rates, patient safety issues, efficiency, accuracy
- **Nurse-sensitive clinical indicators**

The COA-PTP has issued revisions to **DD SD 5 and DD 6** due to the QSEN institute concluding its operation at the end of 2022.

DD SD 5. Submit, for each workplace setting in the program, competency assessment tool(s) used to evaluate residents'/fellows' competencies.

Competencies should reflect the appropriate scope and standards of practice (or consensus-based competencies) and current national competencies.

DD 6. Describe and demonstrate how competency assessment tools integrate the appropriate scope and standards of practice (or consensus-based competencies) in applicable workplace setting(s) and current national competencies.

The COA-PTP has issued clarification on Accreditation with Distinction Standard, **PBL D2**.

PBL D2. Describe how accredited contact hours are offered for 50% or more of the program curriculum (including workplace setting curriculum).

PBL D2a. Submit evidence demonstrating:

- Calculation of how 50% or more of the program (including workplace settings) curriculum awards contact hours
- Detailed program curriculum (including workplace setting curriculum) depicting what is approved for contact hours with accreditors name

A template for PBD D2a. will be provide to all applicants in the Applicant Resource Center.

All ANCC PTAP accredited APRN Fellowship programs will be transitioning to APPFA between 2023-2024.

Re: Learners Licensure Requirement

The Commission on Accreditation in Practice Transition Programs (COA-PTP) has voted to clarify the below areas in the 2020 Practice Transitions Accreditation Program® Application Manual.

The COA-PTP has issued revisions on the learner licensure requirements on **page 6** of the 2020 Practice Transitions Accreditation Program® Application Manual:

The Program Director (PD) ensures that learner(s) in the program meet the following requirements upon application:

- Graduate from an accredited nursing program, and
- Hold a current unencumbered license** (or international equivalent) as an RN.
 - **If state and organizational requirements for prelicensure graduate nursing practice are met, learners awaiting to sit for their first NCLEX may participate in the program unlicensed for up to 90 days.
 - **Learners who fail to obtain licensure within 90 days of starting the program will need to be removed.
